

OFF-LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

RED ROAR LIMITED Licence Number 45/OFF/821/2026

Pursuant to the Sale and Supply of Alcohol Act 2012 (the **Act**), Red Roar Limited (the licensee) is authorised to sell and supply alcohol on the premises situated at 3-5 Raumati Road, Raumati Beach, known as Super Liquor Raumati Village, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

1. Alcohol is only permitted to be sold, supplied or delivered on or from the premises authorised by the licence.
2. A copy of this licence must be displayed so as to be easily read by people entering each principal entrance.
3. Alcohol may be sold or delivered only on the following days and during the following hours:
Monday to Sunday – 9am to 9pm
4. No alcohol may be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
5. All deliveries of alcohol must be signed for by a person aged 18 years or over.
6. The whole of the premises is designated as a **supervised** area.
7. Water must be freely available for drinking at all times alcohol is being supplied free as a sample on the premises.
8. The licensee must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and intoxicated persons.
9. The licensee must implement and maintain the steps proposed in the application for the licence aimed at promoting the safe and responsible consumption of alcohol, and minimising alcohol related harm.
10. The single sales of ready-to-drink (RTD) products and mainstream beer are prohibited. This does not apply to craft beer and cider.
11. The external advertising of product prices is prohibited. This does not apply to brand advertising.
12. The licensed premises situated at 3-5 Raumati Road, Raumati Beach are more precisely identified as outlined in the plan date stamped as received by the District Licensing Committee on 1 November 2018 (displayed on the back of this licence and held on District Licensing Committee file OFF821).

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) either—
 - (i) until the close of the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
 - (i) until the close of the period of 3 years after the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.
